It is a leading national and international authority in the area of drug and alcohol policy and prevention research, and is one of the largest centres of alcohol and other drug research expertise in Australia.

NDRI's mission is to conduct and disseminate policy and practice relevant research that contributes to the primary prevention of harmful drug use and the reduction of drug-related harm. The Institute's research is complemented by the work of the National Drug and Alcohol Research Centre (NDARC) at the University of New South Wales in Sydney and the National Centre for Education and Training on Addiction (NCETA) at Flinders University in Adelaide.

Director's Report

As always, this last year has been a great one for achievements and outputs by NDRI staff, yet it has also been a year of major change.

With respect to achievements, the list of major highlights for 2016 which follows this Director's Report is testament to the depth and breadth of the research and translation work conducted at the Institute. During the year our staff, students and adjuncts produced 136 NDRI publications including refereed journal articles, reports, books and chapters, gave 71 presentations at conferences, seminars and other events in Australia and internationally, and supervised 18 students. In 2016 we were successful in winning \$4,212,625 in competitive NHMRC, ARC and Healthway research grants, and NDRI received around 1200 mentions in the media.

It will be apparent in reading our highlights for the year that although NDRI is an academic institute and does well in terms of academic metrics, a defining tenet of our research activity is a focus on relevance, application and impact through contributing to practical and real world solutions to alcohol and other drug related harm in Australian communities. This involves engagement of community stakeholders in the design and conduct of research and in the translation and application of research findings in local and national policies and strategies.

Late in the year, as consortium partners with lead agency the National Drug and Alcohol Research Centre (NDARC), along with St Vincent's Health Australia and the National Centre for Education and Training on Addiction (NCETA), we were successful in winning an \$8 million grant to run a Centre of Excellence for the Clinical Management of Emerging Drugs of Concern. This four year project involves bringing together clinical and research expertise across the alcohol and other drug sector in Australia and beyond to, beginning with methamphetamine, improve the response to new and emerging substances in this country.

Regarding changes, in August Professor Steve Allsop stood down from the NDRI Directorship after 12 years in the role marked by outstanding commitment to the Institute, Curtin University, and the alcohol and other drug field both in this country and internationally. As Director, Steve played a key role in maintaining and strengthening NDRI's position on both the academic and strategic policy landscape. The good news for us all is that Steve hasn't left the Institute but is now spending more time pursuing his research, supervision, mentoring and policy advice work. Steve's contribution as Director was marked with a celebratory event at NDRI in October with many tributes and stories sent from Steve's colleagues and collaborators nationwide and internationally. With Steve stepping down, I was invited and accepted the position of NDRI Director commencing on September 1 for an initial period of two years. I'm honored to have the opportunity to lead this outstanding, motivated and productive team, and provide stability in the transition to a new funding contract for the Institute. I've had great support from the NDRI staff as a whole, the



NDRI Board, and the management group: Professor Steve Allsop, Professor Dennis Gray and Fran Davis, NDRI Business Manager. Colleagues at the Curtin Faculty of Health Sciences, our funders the Commonwealth Department of Health, and Professors Mike Farrell and Ann Roche, the Directors of NDARC and NCETA, have also provided sound counsel in helping me settle into the position.

The other major change has been the move from our wonderful offices and facilities at Curtin University's Health Research Campus in Shenton Park to buildings in Technology Park, Bentley, adjacent to Curtin's main campus. This move, as a result of the State Government redeveloping the Shenton Park site for a residential precinct, has been difficult. I would like to acknowledge all NDRI Perth staff for their good natured forbearance with the current situation whilst we work with Faculty towards accommodation which is more conducive to our activities at the Institute.

In late 2016 our core funding from the Australian Government was extended until June 2017, and the Government opened a tender call for funding of national alcohol and other drug research centres for a four year period. In anticipation of our funding application being successful, we look forward in 2017, our 30th year, to continuing to work with our community partners to conduct and disseminate high quality research that supports evidence informed policy, strategies and practice approaches to prevent and minimise alcohol and other drug-related harms in Australia.

Highlights and Achievements 2016

- Associate Professor Ted Wilkes was awarded the Australian Medical Association (AMA WA) President's Award, presented to a non-clinician who has contributed greatly to health in Western Australia (see page 7).
- NDRI adjunct and former researcher Dr Susan Carruthers was recognised by Hepatitis Australia with an Outstanding Service Award for Viral Hepatitis Health Promotion for her significant contribution to the viral hepatitis sector and to the health and wellbeing of people affected by viral hepatitis.
- Leading methamphetamine researcher Associate Professor Rebecca McKetin joined NDRI to take up a four-year Curtin University Research Fellowship and lead a program of research on crystal methamphetamine ('ice'). She was awarded \$1.55m by the NHMRC to lead a world-first out-patient trial of a promising new medication, N-acetyl-cysteine (NAC), for ice dependence.
- Professor Suzanne Fraser and Dr Robyn Dwyer were awarded an Australian Research Council (ARC) grant of \$502k to conduct a project investigating barriers to the uptake of 'take-home' naloxone (THN) for reversal of opioid overdose in Australia.
- Professor Suzanne Fraser and Professor David Moore were awarded an ARC grant of \$472k to conduct a study into performance and image enhancing drug (PIED) injecting in Australia.
- Dr Michael Wright was granted more than \$3m in NHMRC and Healthway funding to lead two new projects aimed at transforming Western Australian mental health and drug and alcohol services to provide culturally appropriate access for Aboriginal people.
- Two Melbourne-based NDRI scholars, Aaron Hart and Adrian Farrugia, and one Perth-based NDRI scholar, Amineh Rashidi, completed their PhDs in 2016. Three PhD scholars, Sushil Raj, William Gillmore and Todd Subritzky and one Masters scholar, Rosemary Whalley, commenced their studies.
- NDRI led a major collaborative project, coordinated by Dr Robert Tait, involving colleagues from NDARC, NCETA and elsewhere aimed at providing an assessment of the diverse societal costs of methamphetamine use including those associated with clan lab clean up, policing, health impacts, justice services, traffic injuries, deaths and costs in the workplace.
- NDRI Melbourne's Social Studies of Addiction Concepts (SSAC) team launched *Lives of Substance*, Australia's first dedicated website presenting carefully researched personal stories of drug addiction, dependence or habit (see page 7).

- Alcohol researchers from NDRI, Canada and the USA conducted an international research analysis which found that studies showing health benefits from moderate drinking were flawed. The study was published in the March issue of the *Journal* of *Studies on Alcohol and Drugs*, generating media coverage internationally.
- Professor Simon Lenton and Marina Nelson launched an evaluation of Western Australia's first take-home naloxone (THN) project to coincide with National Overdose Awareness Day, which found that the THN program saves lives and should be continued and expanded.
- A study conducted by researchers at NDRI and the Centre for Addictions Research of British Columbia (CARBC) in Canada found new evidence of a significant link between alcohol consumption and prostate cancer. Published in the journal *BMC Cancer*, the study generated substantial international media interest.
- Adjunct Professor Richard Midford gave an NDRI seminar to launch new research funded by NDRI and FARE (Foundation for Alcohol Research and Education) on the Long-term Evaluation of the Norseman Voluntary Liquor Agreement.
- The Alcohol Policy team launched two National Alcohol Indicators Project (NAIP) bulletins 2016, both of which generated national media coverage: *Trends in estimated alcohol-related emergency department presentations in Australia*, and *Trends in estimated alcohol-attributable assault hospitalisations in Australia*.



NDRI hosted a workshop for a Malaysian university delegation of over 30 students and staff on an academic visit looking at drug and alcohol treatment in Western Australia.

Highlights and Achievements 2016 (continued)

- The School Health and Alcohol Harm Reduction Program (SHAHRP) continued to be widely adopted by organisations nationally and internationally. In addition to Australia, countries using the SHAHRP materials now include Brazil, Canada, Colombia, Ireland, New Zealand, South Africa, Switzerland, the UK, the USA, and international schools in Angola and China.
- The Social Studies of Addiction Concepts (SSAC) program, in collaboration with the Monash University Faculty of Law, hosted a symposium on *Social and Legal Studies of Addiction Concepts* to showcase research and facilitate discussion on emerging approaches and issues in this area.
- NDRI had a strong presence at the fourth National Indigenous Drug & Alcohol Conference with a number of researchers involved as presenters and chairs including Professor Dennis Gray, Anna Stearne, Kim Cartwright and Associate Professor Ted Wilkes who presented the Noel Hayman Oration, speaking about the challenges of Aboriginal alcohol and other drugs policy, and the pressing need for Aboriginal Australians to be involved in the policy process.
- Professor Simon Lenton and Associate Professor Ted Wilkes participated in a cross-party Parliamentary Drug Summit in Canberra at which experts shared experiences and recommendations around harm minimisation and drug law reform.
- Dr Anne-Marie Laslett was a panellist, along with Professor Angela Taft, Clementine Ford and Wendy Steendam, in La Trobe University's Bold Thinking public lecture series event held at the National Gallery of Victoria on the role of alcohol in family violence.
- NDRI's Melbourne office hosted academic visits by three international scholars: Danish postdoctoral researcher Dr Ditte Andersen, Danish PhD student Rasmus Birk, and British addictions researcher Fay Dennis.
- Professor Steve Allsop attended, as part of the Australian Government delegation, the 59th Session of the United Nations Commission on Narcotic Drugs in Vienna and the United Nations General Assembly Special Session (UNGASS) on the World Drug Problem in New York. He also attended the third WHO-UNODC meeting in Geneva as an invited expert.
- Professor Tanya Chikritzhs visited Sweden in August and December as invited co-chair of Systembolaget international review panel meetings on the evaluation of the Swedish alcohol monopoly for the Swedish Government.

- Minister Susan Ley was escorted by Professor Steve Allsop, in his capacity as deputy chair of the Australian National Advisory Council on Alcohol and Drugs (ANACAD), on a tour of alcohol and other drug treatment services in Perth in September.
- Dr Nyanda McBride's book on Intervention Research A Practical Guide for Developing Evidence-based School Prevention Programmes was published, offering a guide when pursuing intervention research in schools and other settings.
- The article Alcohol: taking a population perspective by NDRI researcher William Gilmore and colleagues was published in Nature Reviews Gastroenterology & Hepatology in May and rated in the 97% percentile for downloads both within Nature journals and in general after only a few months in circulation.
- An article by NDRI PhD student Todd Subritzky's on Issues in the implementation and evolution of the commercial recreational cannabis market in Colorado was selected as the Editors' Choice in the January International Journal of Drug Policy.
- NDRI authors Professor Simon Lenton, Adjunct Associate Professor Nicole Lee and Adjunct Research Fellow Stephen Bright contributed seven articles to *The Conversation*, with Professor Lenton's article on *Why do our friends want us to drink and dislike it when we don't?* achieving around 390,000 reads and being republished 21 times.

Lives of Substance launched by NDRI

NDRI Melbourne researchers launched an innovative new website *livesofsubstance.org* in October 2016. Based on an ARC-funded project, *Lives of Substance* is Australia's first dedicated website presenting carefully researched personal stories of alcohol or other drug addiction, dependence or habit.

The website's aim is to generate and present much-needed new insights into the lives of people with drug use experiences of this kind. How do people manage this aspect of their lives? How do they cope with the stigma associated with addiction? What challenges do they face and how do they cope and thrive?



In addressing these questions, *Lives of Substance* offers new perspectives on people often dismissed or stigmatised as dysfunctional, dangerous or sick. Drawing on in-depth qualitative interviews, the website presents detailed life stories of people who consider themselves to have an addiction, dependence or drug habit. Also presented are key themes found in the interviews:

- How alcohol and other drug use fits into everyday life
- Coping with stigma and discrimination
- Looking after health and well-being
- Seeking help or initiating change

Themes are presented using video re-enactments, original audio recordings and written extracts from the interviews.

The site was launched with the help of writer Kate Holden and harm reduction pioneer Jenny Kelsall. Speaking at the launch, Holden commented:

We have much to learn from people who are part of our community. People who use drugs are not 'them' but 'us' [...] This is a website that I believe has the power to change lives.

Planned and designed with the help of a large national advisory panel, *Lives of Substance* aims to support people who take drugs, inform the public about their many different life experiences, and act as an information and training resource for professionals.

AMA award for Aboriginal health champion

NDRI's Associate Professor Ted Wilkes was recognised by the Australian Medical Association (WA) in 2016 for his distinguished career championing the health of Indigenous Australians.

The AMA President's Award, given to a non-clinician who has contributed greatly to health in Western Australia, was received by Associate Professor Wilkes at the AMA (WA) Annual Charity Gala Dinner and Awards Night - an annual event to recognise great achievements in health leadership and medical research.

Associate Professor Wilkes has collaborated with the AMA (WA) over many years to improve health outcomes for Indigenous Australians, producing the landmark publication *A Medical Practitioner's Guide to Aboriginal Health* in 1998 – a resource that is still considered vital by any doctor who has interactions with Aboriginal communities across the country.

Associate Professor Wilkes is a leader of NDRI's Aboriginal Research Program and plays an active role in capacity building and research. He is a member of the Australian National Advisory Council on Alcohol and Drugs, and was previously a member of the Australian National Council on Drugs and Chair of the National Indigenous Drug and Alcohol Committee.



Research Overview

NDRI is amongst the largest centres of alcohol and other drug research expertise in Australia. Recognising that problems associated with alcohol and other drug use are complex, a multi-disciplinary approach to research is pursued. NDRI staff come from diverse backgrounds, including psychology, epidemiology, biostatistics, sociology, anthropology, medicine and public health. A range of high level skills and a wealth of knowledge contribute to innovative research approaches.

NDRI works closely with a diverse range of stakeholders, and a culture of collaboration ensures that much of its work is further strengthened through partnerships with other research bodies, government, and non-government organisations locally, nationally and internationally. The Institute is a designated World Health Organization (WHO) Collaborating Centre for the Prevention of Alcohol and Drug Abuse.





NDRI received around 1200 mentions in the media during 2016, with the provision of expert comment and evidence based research further enhancing NDRI's efforts to disseminate its research findings widely and to inform and participate in alcohol and other drug policy development in Australia.

NDRI research and expert commentary appeared in local, national and international electronic and print media, including news and opinion websites, on a diverse range of subjects relating to alcohol and other drug use, reflecting the variety of expertise at the Institute. In addition, NDRI used its social media channels to disseminate research findings and media items, with the Institute achieving more than 1300 Twitter followers or Facebook likes. NDRI authors contributed seven articles to *The Conversation*, achieving around 492k reads and being republished 72 times.

Topics that generated the most media interest included moderate drinking and health benefits; the link between alcohol and prostate cancer; methamphetamine use, harms and treatment; 'study' drugs; take-home naloxone and overdose prevention; compulsory treatment and drug rehabilitation; new psychoactive substances; and alcohol and hangovers.
