About NDRI

The National Drug Research Institute (NDRI) is one of the largest centres of alcohol and other drug research expertise in Australia.

NDRI is based at Curtin University in Perth, Western Australia. NDRI is an integral part of the national strategy aimed at minimising the harm associated with legal and illegal drug use in Australia. Our role is to conduct and disseminate high quality research that contributes to effective policy, strategies and practice to prevent and reduce harmful alcohol and other drug use. Our research is complemented by the work of the National Drug and Alcohol Research Centre (NDARC) at the University of New South Wales, the National Centre for Education and Training on Addiction (NCETA) at Flinders University, and the National Centre for Youth Substance Use Research (NCYSUR) at the University of Queensland.

NDRI is supported by core funding from the Australian Government under the Drug and Alcohol Program and also receives significant funding from Curtin University. Additional competitive funds are attracted from a range of state, national and international funding bodies such as the National Health and Medical Research Council (NHMRC) and the Australian Research Council (ARC).

Chair's Report

Welcome to the National Drug Research Institute's Annual Report for 2020. This report provides a brief overview of the Institute's activities during what was certainly an extraordinary year.

COVID-19 was obviously the dominant feature of the past 12 months, with all of us dealing with the onset of the virus and then changing our practices to comply with regulations to keep our community safe.

It was pleasing to see how my NDRI colleagues navigated the challenges of 2020 and were able to continue producing meaningful outputs. Researchers and business support staff adapted quickly to working from home. Perhaps more importantly, the research for which NDRI is well-known was able to continue with, in many cases, a shift from face-to-face to virtual data collection.

In fact, across all its research programs in 2020, NDRI continued to produce important outputs to inform alcohol and other drug (AOD) policy in Australia. Most pleasing was, that in many cases, the pandemic was turned into an opportunity with innovative NDRI researchers incorporating the impact of coronavirus on AOD consumption and harm into existing projects, or directly examining links between coronavirus and AOD.

In the context of the challenges outlined above, it is even more satisfying that NDRI was able to expand its research program in some key areas. For example, in the second half of the year the Institute appointed a new leader for its Aboriginal and Torres Strait Islander Research Program, with further appointments expected in 2021 to grow the team.

Around the same time, NDRI re-established a physical presence in the Eastern States through a collaboration with the Burnet Institute in Melbourne. While making practical sense, with each Institute's work complimenting the other, the collaboration also brings together two institutes worldrenowned in our field. Again, I look forward to seeing the research produced from the



growing NDRI Melbourne team through 2021 and beyond.

In closing, I warmly acknowledge and thank the academic and support staff at NDRI for their commitment and leadership during 2020. Similarly, I express my sincere thanks to my fellow NDRI Advisory Board members from across Australia for their time, commitment and contribution during a difficult 12 months.

Our collective ability to not only survive but prosper during these challenging 12 months gives me great confidence in the continued longevity of the Institute, and I look forward to more productive years ahead.

Director's Report

As has been the case everywhere, during 2020 NDRI has been dealing with the impacts of COVID-19 and the associated countermeasures. While COVID has impacted on our research activity, we have nevertheless continued to conduct high quality research to inform alcohol and other drug (AOD) policy and practice in Australia and, looking to the future, continued to develop our research program. In 2020, program development highlights have included the reopening of an NDRI office in Melbourne and developments in our Aboriginal and Torres Strait Islander Research Program.

In October 2020, we announced the opening of NDRI's new Melbourne office, a collaboration with the Burnet Institute that formalised a longstanding relationship between the two internationally-renowned research Institutes. Based at Burnet's premises in central Melbourne, NDRI Melbourne will serve to further advance NDRI's research presence and impact in Victoria and the eastern states more generally. Professor Paul Dietze, Director of Burnet's Behaviours and Health Risks Program, has been appointed as Professor and Head of NDRI Melbourne, on a half-time basis with his existing Burnet position.

With the new arrangement strongly supported by the NDRI Advisory Board, Curtin University and the Commonwealth Department of Health, the new NDRI Melbourne office will build on the strengths of NDRI and Burnet Institute to conduct high quality research that is valued by policy makers, practitioners and communities in Australia and internationally. Further research appointments and PhD scholarships are expected to grow the office from 2021 onwards.

In the previous month, NDRI took a significant step in the renewal of its Aboriginal and Torres Strait Research Program with the appointment of Dr Jocelyn Jones, a leading Aboriginal epidemiologist with extensive experience in Aboriginal health and justice services, to lead the Program. It is appropriate that we have a Nyoongar woman, with Wadjuk, Ballardong and Palyku connections to the land in Western Australia, leading this program of community-driven research that aims to change policy and improve AOD related outcomes for Aboriginal and Torres Strait Islander people.

Unsurprisingly, COVID had both organisational and project-specific impacts in 2020. Consistent with revisions to WA State Government and University guidelines that reflected the low rate of community spread in WA, we saw the majority of staff return to working from the NDRI Perth offices after a period working from home. We have, of course, been complying with social distancing, sanitation and infection control procedures while dealing with COVID-related organisational challenges and uncertainties.

At a research project level, while a few affected projects were put on hold during the year, most were reshaped away from face-to-face contact with participants towards phone and online interviews. Furthermore, some projects were started and many ongoing projects were modified to measure and document the impact of COVID on alcohol and other drug use



in Australia. This was important to provide the most up-to-date information for policy makers and practitioners to help reduce drug-related health, social and economic harm. As Director, I acknowledge the fantastic work of NDRI researchers and our business support team in enabling the ongoing research work of the Institute during these challenging and disruptive times.


Despite the pandemic, the quantity and quality of the Institute's research activity has continued. While travel restrictions meant face-to-face presentations at conferences both in Australia and internationally effectively ceased, other outputs were maintained. During the year, our staff and students produced more than 120 publications including refereed journal articles, reports, books and chapters; gave 21 presentations at conferences, workshops, seminars and other events in Australia and internationally; and supervised 11 postgraduate students. In 2020, we received \$1.2 million in externally competitive and commissioned research funding, made 6 submissions to Government inquiries and reviews, and NDRI research or expertise appeared in some 1315 media stories.

To conclude, during this unprecedented year of change and challenges, I thank our funders — the Australian Government Department of Health and Curtin University — and the Chair and members of the NDRI Advisory Board, who have provided sound support and a keen interest in our work. In this year of so much uncertainty, this support has been centrally important to enable the work of NDRI researchers. Importantly, I convey my thanks and admiration to the researchers, students and business support staff who make up the NDRI team for their contribution and commitment throughout this extraordinary year.

Highlights and Achievements 2020

- After several months of negotiation for an ongoing collaborative arrangement and co-location environment with Burnet Institute, NDRI's Melbourne Office was opened in June 2020, with one of Australia's leading alcohol and other drug researchers Professor Paul Dietze appointed as the Head of NDRI Melbourne (see Director's Report).
- NDRI welcomed Dr Jocelyn Jones as the Indigenous Research Program Lead in September. A Nyoongar woman, with Wadjuk, Ballardong and Palyku connections to the land in Western Australia, Dr Jones is a leading Aboriginal epidemiologist with extensive experience in Aboriginal health and justice services. She is well known to the Institute, having collaborated over many years with the team working on the Indigenous program (see Director's Report).
- An NDRI team, led by Professor Steve Allsop and Dr Robert Tait, completed two major 'social costs' reports for the Department of Health: one on the social costs of non-medical use of opioids, and the second focused on cannabis. Work was completed on the Social Cost of Opioids project and the report released in May 2020, generating extensive media interest to the equivalent of \$10 million in advertising. The Cannabis report was finalised in July 2020.



- Released in February 2020, the YAWG website (pictured) has been developed by NDRI researchers as a resource for service providers who work with young Aboriginal women and girls. It aims to share their stories and experiences around fighting, drinking and offending to help service providers better understand how to support and engage with them. Available at www.yawg.info, the website is based on the findings of the Young Aboriginal Women and Girls project.
- The new book, *Legalizing Cannabis: experiences, lessons and scenarios*, edited by Tom Decorte, Simon Lenton and Chris Wilkins, was published by Routledge in February. The 400 page volume brings together leading drug policy experts to examine current examples of cannabis legalisation and other cannabis law reforms, and lessons that can be drawn from attempts to regulate alcohol, tobacco and other psychoactive substances, to inform effective regulation of legal cannabis markets.

- Professor Tanya Chikritzhs, Dr Robert Tait, Will Gilmore and Professor Steve Allsop were awarded \$500,000 to undertake a social costs of alcohol study commencing in July 2020. This is the fifth in the 'social costs' series of reports, following methamphetamine, tobacco, opioids and cannabis.
- PhD scholar Anna Stearne spent two days at the SBS studios in Sydney as part of AusSMC's third Indigenous media mentoring program. The program, which provides intensive training with Indigenous journalists and mentors, aims to provide Indigenous scientists with the skills and confidence to engage proactively with the public through the media.
- NDRI Alcohol Program Lead Professor Tanya Chikritzhs had her role with the National Health and Medical Research Council National Alcohol Guidelines Committee extended to assist in disseminating the new Australian Drinking Guidelines. The new guidelines generated significant media interest.
- Jodie Grigg's PhD award was conferred in May. She also presented at the Mark Liveris Student Research Seminar, provided a virtual lecture on illicit drugs to second year medical students at the University of Notre Dame, received a 'Certificate for Reviewing' from the *International Journal of Drug Policy* recognising her reviewer contributions to the journal, and delivered a seminar on her PhD findings for the Victorian Substance Use Research Forum (VSURF).
- Professor Steve Allsop attended the Commission on Narcotic Drugs annual meeting at the United Nations Office of Drugs and Crime Vienna as part of the Australian Government Delegation (technical advisor). He also attended the Global Alcohol Policy conference in Dublin in March.
- Anna Stearne presented the paper International evidence of First Nations Peoples' Self-Determination in Alcohol-Related Policy Development at the 6th Global Alcohol Policy Conference 2020 in Ireland in March. The paper was a brief review of how self-determination has been embedded in development and implementation of effective evidencebased alcohol policies.
- Professor Steve Allsop was appointed Chair of the National Ice Action Evaluation Strategy Evaluation Plan Advisory Group and became a member of the COVID-19 Mental Health, Alcohol and Other Drug Community Services Taskforce (WA). He also took part in two WA Premier COVID-19 round tables: Mental Health and Alcohol and other Drugs, and Health and COVID-19.
- The 'Beyond Violence' research project with incarcerated women and Aboriginal girls was showcased in Curtin's *Future of Health*, *Public Health* publication.
- Professor Tanya Chikritzhs contributed to a Commentary in Drug and Alcohol Review outlining The burden of alcohol on healthcare during COVID-19 with international colleagues from the United States, Canada and Sweden.

- Professor Steve Allsop was a reviewer for the World Health Organization (WHO) on resource materials developed in relation to Helping Adolescents Thrive, part of a program on which he was an expert advisor in 2019 on preventing and responding to mental health problems among adolescents.
- Dr Jodie Grigg's *Increasing trends in self-reported use of nitrous oxide among WA EDRS samples* became another example of NDRI research impact and how research outputs contribute to practice and policy changes. The EDRS Bulletin documented increasing rates, frequency and episode specific dosages of use of nitrous oxide, especially among WA respondents in the EDRS sample, and led to the issue bring raised with the Drug Early Warning System group (see breakout box below).
- Dr Nyanda McBride was invited to contribute expertise and collaborate on a Telethon Kids Institute submission to the Australian Department of Health: The Drug and Alcohol Program: Fetal Alcohol Spectrum Disorder (FASD) – Consumer Resources project. She was also invited to be an expert advisor on the FASD resource initiative funded by the WA Department of Health.
- The Wild Butterfly documentary highlighted stigma and discrimination around drug use. Professor Steve Allsop was involved in the film.

- Dr Julia Butt provided the Australian Government Department of Health with an updated version of her review on kava use among Aboriginal and Torres Strait Islander people, which was very well received by the Department. Dr Butt also presented the What do we know about the impacts of cannabis use in Aboriginal and Torres Strait Islander communities? webinar for the Alcohol and Other Drugs Knowledge Centre.
- Professor Steve Allsop joined the Advisory Group for the evaluation of *Sideffect*, a school based drug education project, funded by the Department of Health and coordinated by Edith Cowan University. He was also part of the Monash University Faculty of Medicine, Nursing and Health Science review panel for the Monash Addiction Research Centre.
- NDRI PhD scholar Julia Stafford had a paper published in the *Journal of Studies on Alcohol and Drugs* showing that almost all alcohol industry submissions to policy consultations in Australia over a five year period presented a distorted view of the scientific evidence, including misuse of evidence and denial of the effectiveness of strategies supported by evidence.
- Dr Nyanda McBride and her colleagues in the SHAHRP Brazil team had funding success for further work on SHAHRP Brazil through the European Varela.

Research informing practice: 'early warning' on nitrous oxide use

An EDRS Drug Trends bulletin led by Dr Jodie Grigg was publicly released in July on *Increasing trends in self-reported use of nitrous oxide among WA EDRS samples*.


The Bulletin documented increasing rates, frequency and episode specific dosages of use of nitrous oxide especially among WA respondents in the EDRS sample.

Nitrous bulbs, or 'nangs', have often been seen as low risk but heavy use of nitrous is associated with vitamin B12 depletion and serious neurological consequences.

The bulletin documented up to 10 24/7 delivery services with a number of social media vendors providing nitrous along with balloons and masks 'for party use', many promoting bulk buy discount specials.

The bulletin was noted by our colleague Clinical Toxicologist Dr Jessamine Soderstrom of Royal Perth Hospital as it coincided with increased presentations in nitrous related spinal cord and neurological injury at RPH.

As a result, the issue was raised with the Drug Early Warning System group chaired by the Mental Health Commission. Dr Grigg is centrally involved with a view to providing urgent advice to clinicians



potential users regarding

risks, along with consideration of policy changes. Both Dr Grigg and Professor Simon Lenton sit on the steering group to help plan a multipronged approach, involving a warning system for clinicians, reviewing and possible tightening of regulation, and a targeted harm reduction campaign.

This is another example of NDRI research impact and how research outputs can be leveraged to contribute to practice and policy changes to reduce drug related harm.

The National Drug Research Institute (NDRI) is among the largest centres of alcohol and other drug research expertise in Australia. Since our inception in 1986, we have conducted novel, high quality, strategic research that aims to inform Australia's response to alcohol and other drug problems at local, state and national levels. NDRI focuses on research and other outputs that have policy and practice relevance and impact. We work in partnership and collaboration with Australian, state and local governments; with health, social and law enforcement services; and with communities. To ensure broad and enduring impact, capacity building is central to our work. Our researchers come from diverse backgrounds including psychology, epidemiology, biostatistics, sociology, anthropology, medicine and public health. A range of high level skills and a wealth of knowledge contribute to innovative, multi-disciplinary research approaches. ALCOHOL AND OTHER DRUG POLICY AND STRATEGIES

Informing, evaluating and investigating policy to ensure the most effective evidence based measures are in place

Policy research takes a broad approach to alcohol and other drugs (AOD) that spans issues that influence social, health, regulatory and enforcement policy in Australia and overseas. It focuses on conducting targeted data collection and trend analysis and monitoring; and evaluating the impact of various models of regulatory and legislative controls and policies on AOD use and its consequences. It aims to inform activities across the sector, in particular government policies and strategies, and has a major focus on assessing the impact of changes in policy at national and international levels, investigating models of control in other countries to build the evidence base, providing strategic advice to government, and informing community debate.

NEEDS OF ABORIGINAL AUSTRALIANS

Working with Aboriginal Australians to prevent and reduce alcohol and illicit drug harm

This research contributes to prevention and reduction of the burden of harm caused by alcohol and other drugs (AOD) among Aboriginal Australians. Research focuses on the inter-related topics of changing patterns of AOD use, factors related to harmful use, more efficient and effective provision of services, and improved policy responses. Research is based on well-established partnerships with Aboriginal community controlled health organisations, with Aboriginal community stakeholders and organisations actively involved in all aspects of research from planning through to translation into policy and strategies.

INNOVATION IN PREVENTION AND EARLY INTERVENTION

Innovative and effective ways to delay or prevent alcohol and other drug use and harm

This research aims to prevent early and problematic use of alcohol and other drugs (AOD) and adverse consequences, particularly during childhood and adolescence. It includes a focus on early intervention programs for high risk children, families and communities and incorporates research and evaluations of the social determinants of AOD use and the impact of AOD use during pregnancy. The research builds on international work exploring social and economic benefits of prevention and early intervention, particularly among marginalised populations, on more equitable health outcomes, reduced hazardous and harmful drug use, safer children and more cohesive communities.

The National Drug Research Institute (NDRI) widely disseminates its research findings to increase awareness of drug related harm and effective prevention strategies, and to inform community debate and public health policy and practice. Research is disseminated through various means, including publications, presentations and the media, to policy makers, practitioners, public health professionals, other researchers, interest groups and the community. Media

Traditional, online and social media are important conduits for our research to reach the community and inform policy. NDRI has built a reputation as a reliable source of scientific information and expertise on a range of issues concerned with the prevention of alcohol- and drug-related harm.

NDRI received 1,315 mentions in the media during 2020, with the provision of expert comment and evidence based research further enhancing NDRI's efforts to disseminate its research findings widely and to inform and participate in alcohol and other drug policy development in Australia.

NDRI research and expert commentary appeared in local, national and international electronic and print media, including news and opinion websites, on a diverse range of subjects relating to alcohol and other drug use, reflecting the variety of expertise at the Institute. In addition, NDRI used its social media channels to disseminate research findings and media items to more than 2600 Twitter or Facebook followers. NDRI authors contributed 14 articles to *The Conversation*.

Topics that generated the most media interest included: the impact of COVID-19 on alcohol and other drug use; the social costs of opioid and cannabis use; NHRMC drinking guidelines; stigma and discrimination against people who use drugs; changes in cannabis policy in Australia and overseas; access to treatment; public education campaigns; fatal overdoses; and the risks of using alcohol as stress relief.
